Announcement

of the results for the election to the IT:U University Assembly 2025

In the election for the University Assembly of IT:U, which took place from April 22 to April 23, 2025, 16 members were elected to the University Assembly.

12 members were elected from the university's scientific and artistic staff in accordance with § 24 para. 2 item 1 lit. a and b of the IT:U Law (=Scientific and Artistic Staff).

4 members were elected from the staff in accordance with § 24 para. 2 item 2 of the IT:U Law (=General Staff).

The election results and the distribution of mandates for the University Assembly are announced - separated by electoral body – as follows:

¹ In accordance with the preliminary bylaws of IT:U, section VIII, § 31 (5), whereas if several equally ranked candidates are eligible for the final mandate to be awarded, the decision had to be made by drawing lots, conducted by the chairperson of the election commission. The drawing of lots must take place transparently in the presence of the other members of the election commission and must be properly documented.

A coin toss was chosen as the method for drawing lots.

¹ In accordance with the preliminary bylaws of IT:U, section VIII, § 31 (5), whereas if several equally ranked candidates are eligible for the final mandate to be awarded, the decision had to be made by drawing lots, conducted by the chairperson of the election commission. The drawing of lots must take place transparently in the presence of the other members of the election commission and must be properly documented.

A coin toss was chosen as the method for drawing lots.

² In accordance with the preliminary bylaws of IT:U, section VIII, § 31 (4), whereas in the event that women would receive less than 50% of the mandates within an electoral body, unelected female candidates with the highest number of votes shall be ranked ahead of the elected non-female candidates with the lowest number of votes, until a 50% proportion of women is achieved. This process shall be repeated until the 50% threshold is reached or there are no more women on the ranked list for the respective electoral body.
